



LOSABLE BONUS

Trade with 25% Losable Bonus offered for the **Etiq Markets** clients for deposit a minimum amount of \$50 for their trading account. Bonus will be credited into account through an MT4 live account. There is maximum claim for this bonus with capped at \$2,500 for multiple deposit or single deposit. This promotion is valid until 31/3/2021.

PARTICIPANTS

The 25% Losable Bonus program is available to all new, retails and existing direct clients. The bonus program can be applied to Elite and Advance Account only.

ELIGIBILITY

- a. All applicants must be 18 years old or older, subject to our general Terms of Business and Terms and Conditions.
- b. All clients who follow the requirements of our Terms and Conditions are eligible to apply for the bonus promotion.
- c. If an eligible client has been disqualified from the offer for any reason, he/she cannot apply for the same promotion again.

RESTRICTION

- a. No staff members, and/or their relatives, of Etiq Markets or any associated company, may take part in this promotion.
- b. The offer is limited to one per household and one per person. Bonus will be credited into one account only, even if clients have multiple accounts and have deposits in those accounts.
- c. This trading credit bonus cannot be transferred between trading accounts within Etiq Markets.

TERMS & CONDITIONS

- a. The bonus promotion is 25% of the deposit with the minimum deposit requirement \$50.
- b. The bonus promotion can be applied for both deposit and redeposit and cannot exceed \$2,500 in total.
- c. The bonus will be valid for two calendar months from the time that the bonus has been credited to the account.
- d. Applicants are not allowed to make the (Capital + Bonus) withdraw during the bonus period, however any profit made from the (Capital + Bonus) can withdraw.
- e. However, if client account balance is below the capital and would like to request full withdrawal, Etiq Markets has rights to deduct the bonus proportionate to the deposit amount.

- h. The stop out level will be 50%.

- k. The client can submit a bonus request no later than 5 business days after the initial deposit. Requests submitted outside of this time limit will not be processed.
- l. If the trader loses the capital and wants to withdraw the remaining funds in full, the company will calculates how many times the customer actually receives the bonus benefit and will not release the withdrawal amount until after deduction.

Example:

The customer has a deposit of \$1000 on day 1 and a credit bonus of \$250. The balance available to him was \$1,250, and on the second day he had \$400 left in his account balance, and he decided to deposit another \$1,000. The company will give another losable bonus benefit of \$250. Then the customer's available funds will be **\$400 + \$1000 + \$250 = \$1650**. After a few days, the customer's balance is \$600, and he decided to make full withdrawal. However, about his account, the available balance for him to withdraw will be \$100 (because: first deposit: \$250 bonus + second deposit: \$250 bonus = \$500 bonus) balance \$600 - \$500 reward = Balance \$100



TERMINATION

- a. If an eligible client withdraws funds from his/her account during the promotional period, the account will be disqualified from the offer.
- b. Etiqu Markets is not responsible for informing the client when the bonus is removed from the account.

ADD-ON CONDITIONS

- a. Etiqu Global Markets reserves the right to amend, cancel or restrict this offer to any applicant or customer.
- b. If Etiqu Markets detects that the client has abused the terms of this promotion, Etiqu Markets reserves the right to withdraw the trading credit bonus or terminate the client access to the services provided by Etiqu Markets.
